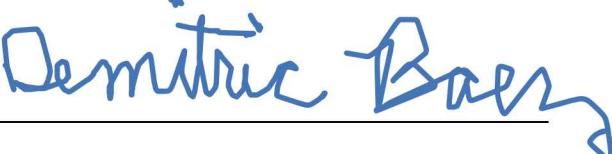

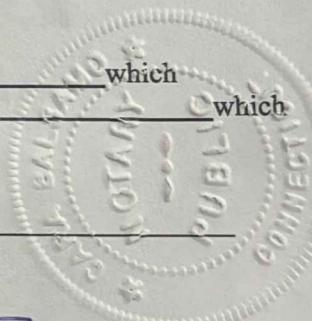

2. *The Respondent is Connecticut State Colleges & Universities (CSCU), whose business address is 61 Woodland Street, Hartford, CT 06105.*
3. *The Respondent is a State University System who employs more than 15 people.*
4. *I have ADHD-C and Autism Spectrum Disorder (High Functioning Autism or "HFA").*
5. *I began my employment with Eastern Connecticut State University, whose business address is 83 Windham St., Willimantic, CT 06226, on May 30, 2025, as the Graduate Intern Hall Director for Burnap Hall. As part of my compensation for working at Eastern, I was compensated with an annual monetary and monthly meal stipend, live-in apartment, and a tuition waiver for my studies at Central.*
6. *I was enrolled at Central Connecticut State University, whose business address is 1615 Stanley St., New Britain, CT 06050, in the Master's of Science in Student Development in Higher Education (SDHE) program from approximately May 2025 to November 5, 2025.*

  1. Corey still viewed my TikTok on December 18 at 1:59 PM, causing me to rescind my final good faith offer to settle with Respondent.

*Role: Executive Director of Civil Compliance*

**Charges**

**I. Violation of 34 C.F.R. § 106.71 - Retaliation**

- A. November 17, 2025: Dr. Atkins pressured me when I attempted to explain my Complaints.
  1. In particular, Dr. Atkins pressured me most when it came to reporting the sexual harassment by Mr. Corey.
- B. November 17, 2025: Dr. Atkins laughed at me when I mentioned that I sought a supportive measure per 34 C.F.R. § 106.44 since the retaliatory firing rendered me homeless.
  1. My multiple requests to him for the housing supportive measure were either ignored or met with one-line responses.
    - a) November 25, 2025: Atkins responded "Mr. Baez, Received. Thank you," to one of my requests.

*Role: Associate Director for Residential Engagement*

**I. Charges - Violation of 34 C.F.R. § 106.71 - Retaliation**

- A. August 7, 2025: at 4:45 PM, Branham emailed all affected parties regarding RA switch from Burnap (my hall) to Winthrop and vice versa.
  1. This was the first time I heard of such information.
    - a) See Corey Section A(17) for more.
  2. August 8, 2025: Branham led meeting regarding RA switch reason. See Corey Section A(17) for more.
    - a) At this meeting, Branham told me my work deadlines were not being met.
    - b) She also told me that I should not have emailed the affected parties to inform the RAs affected that I was "just informed" regarding the switch,
    - c) Branham said I should have acted as if I knew all along.
      - (1) Corey agreed, saying I could be seen as triangulating.
      - (2) I took this to be discrimination on the basis of my autism.
- B. On August 28, 2025: during a meeting Corey pretextually called:
  1. See Corey A(22) for more.
  2. I informed Branham and Corey that I had been diagnosed with Autism Spectrum Disorder.
    - a) Immediately after this, Ms. Branham said that I see things in "black and white."
- C. September 4, 2025: I met with Branham for a 1:1 meeting from approximately 2 PM to 3 PM:
  1. During this meeting, Ms. Branham told me that she knew I "like things black and white."
    - a) I believe was a reference to the perception that people with autism think in a binary manner.

2. Branham also told me that because I had missed so many deadlines, if anyone contacted Eastern for a job reference, the contacted official would have to be honest about it.
  - a) I took this to mean that Eastern intended to give me a negative job reference.
3. Refer to Corey Section A(9) for the below:
  - a) Ms. Branham told me she "would bet her retirement" that Mr. Corey meant no harm when he made the comment regarding my salary.

1. *On July 4, 2025, I connected with a male student from CT State Quinebaug Valley, on a dating app.*
2. *On this evening, told me he has coprophilia.*
3. *is about twice my body mass and I was too afraid to say no to his requests.*
4. *Between July 4 and July 13, 2025, I was sexually assaulted by*
5. *I was chemically coerced to ingest magnesium citrate and milk of magnesia to entertain coprophilia.*
6. *also sexually assaulted me within the above timeframe by smacking my anus against my will.*
7. *smacked my anus because he was sexually aroused by the haircut he gave me, which was poorly faded and made me feel self-conscious.*

3. Between June and July 2025: repeatedly asked me if I wanted rides across the campus for business matters in his personal orange Jeep Renegade with black stripes.
  - a) He engaged in this behavior despite me rejecting his advances every time.
4. On June 13, 2025: told me and (graduate intern hall director for Noble Hall) that he got his male cat, Roi, because it was "too quiet" while he was the HD of Mead Hall.
5. In June 2025: Informed me that regarding Roi, he will "throw him around," which I questioned, and he clarified that he spins Roi on the ground to play with him.
6. Between June 2 and July 25, 2025: Held multiple training meetings with me in the mailbox office of Eastern Housing - whose table did not permit enough space for me to extend an arm without making contact with him.
7. During one of these meetings, he moved his items as I moved mine to clear room for binder writing utensils; he touched my hand for longer than usual.
8. By contrast, Emmanuel Augustin, Eastern's Residence Life Coordinator for Burr, Noble, Shafer, and Winthrop Halls, trained the graduate

- intern hall director for Noble Hall, in the Student Affairs Conference Room, adjacent to the Housing Office at Eastern.
9. July 2025: during a 1:1 meeting, he said to me, “Well, *you* are the one who signed up for the job” when I told him I was looking to augment my income.
- a) This was after Eastern HR admitted to me via email that an administrative error caused my address to be incorrect, causing credit issues for me.
  - b) Corey told me to keep him “updated” on “how that goes” when I informed him of issue in early July.
  - c) The error led to a charge-off balance of approximately \$9,000, causing a cascading negative credit rating due to the charge-off payments increasing my monthly payments by approximately \$400 monthly.
  - d) This is causing me current financial duress.
10. On July 3, 2025: returned the Burnap Hall Director duty cellphone to me after covering me for my class at and commute to/from Central.
- a) I requested to meet in front of Niejadlik such that the Student Center entry was directly visible.
    - (1) He told me that “we can meet at the bottom” via text message.
  - b) I was intercepted by him from the basement exterior entrance/exit door in alleyway of Niejadlik
  - c) He wore a black t-shirt and a pair of boxer-brief length light blue shorts.
    - (1) This caused me psychological damage that led to issues with CT State Quinebaug Valley student
11. On or around July 11, 2025: Corey said, “Ooh, I like your haircut!” while smiling, in response to poor haircut                    gave me.
12. July 14, 2025: I nonverbally indicated to Corey that I experienced chemical coercion the prior weekend.
- a) Nonverbal cue: holding my stomach in pain while seated
    - (1) Corey indicated that if I wanted to discuss the matter, he is a mandated reporter who would need to forward the concern to Eastern’s Title IX Coordinator, Mrs. Sara Madera Judge.
      - (a) This was while at work
  - b) An hour later, Corey texted me to let me know he was willing to come over to my hall outside of work hours or via phone at “any time” if I needed to talk.
13. On or around July 17, 2025: I reported the chemical coercion and unwanted sexual contact to Mr. Corey in a private meeting.
- a) Located in Housing Office Mailbox Room.
    - (1) I indicated to Mr. Corey that I am “not promiscuous” and a “gay man.”
      - (a) He said to me, “That doesn’t sound like a balanced relationship,” when I told him how I was treated by my assailant.
      - (b) He also said to me, “I don’t know if this counts as a Title IX issue.”
        - (i) This caused me psychological trauma, effectively forcing me to explain that coprophilia was the nexus of actions.

- 15. August 5, 2025: Mr. Corey and an impending RA were alone in Burnap when I left to get RA welcome package gifts as appreciation for their work.
  - a) RA accepted candy from me as a thank-you for starting door decals while working as a summer RA in \_\_\_\_\_ Hall.
    - (1) Thanked me and complimented my office setup.
  - b) RA: \_\_\_\_\_ assigned to Burnap from Spring 2025 to August 7, 2025 at 4:45 PM.
    - (1) Corey copied on email regarding switch - I received no forewarning.
      - (a) RA Move-In was August 8, 2025.
    - c) After what I suspect is Corey's termination, \_\_\_\_\_ viewed my TikTok video on what happened in brief.
      - (1) Link to video: <https://www.tiktok.com/t/ZTrtgdbGR/>
- 16. August 7, 2025: Received email at 4:45 PM with Corey copied on it from Branham stating \_\_\_\_\_ switched from Burnap to Winthrop.
  - a) Corey never briefed me about such a change.
- 17. August 8, 2025: Corey sat in on meeting with Branham to inform me of switch:
  - a) Branham opened the meeting and led it.
    - (1) Branham is on Housing Leadership, who typically deals with high-level issues or local issues that spiral out of control there.
      - (a) Branham stated that \_\_\_\_\_ was uncomfortable with my disclosures (dates in relation to August 8 shatter proximity of time defense):
        - (i) June 2025: homelessness prior to being hired (a protected class)
        - (ii) My Title IX sexual assault disclosures to \_\_\_\_\_
      - (a) July 18, 2025: \_\_\_\_\_ witness to \_\_\_\_\_ and I conversing about my Title IX issue.
        - (i) \_\_\_\_\_ said, "Fuck that guy; if I see him in Burnap, I'm calling the police!" in support of me.
  - b) Corey told me that if the RA and I ended up in a lunch line with the RA, I was to "go on your [my] phone and mind your [my] business."

    - (1) Corey said “I think I do” as he gets distracted if someone walks by while he works in his office, referencing ADHD.
    - (2) He also suggested that I could cause triangulation by telling the RAs that I was just made aware of the change.
  - e) Approx. August 11, 2025: I informed Corey that I thought a mediation with the RA would have been an appropriate measure to take as the last-minute change caused undue stress on all involved parties
    - (1) Corey countered with narrative that I was likely making things up in my head.
    - (2) Corey also told me that I was not allowed to give the RA the welcome gift basket I had gotten them.
    - (3) He also stated that he would not approach her to check in on her.
18. August 13, 2025: Corey texted me “I’ve got your ID” in reference to holding my university-issued ID card.
- a) Corey did not have my consent.
    - (1) I was in the restroom when he took my card back from Student Center.
19. August 19, 2025: Corey tapped me on my back very hard.
- a) He then apologized to me with an inflection I never heard him use before or after that.
    - (1) His voice got progressively deeper at the end of his apology:
      - (a) “Sorry I made you give back the picturreeee.”
      - (i) The last part of the word “picture” was elongated.
20. August 21, 2025: At RA Training Dinner event, gave my Burnap RAs and I the board game, “Sorry!”
- a) I took this to mean that the RA were warning us of Mr. Corey’s predatory behavior, as corroborated by 15(c)(1) of this section.
21. August 26, 2025: Corey, via Serignese, set up meeting with me regarding “all things balloony” in Burnap.
- a) I was the primary recipient of the email.
    - (1) Serignese emailed me at 3:25 PM.
    - (2) Corey answered at 4:26 PM on my behalf (proximity of time).
22. August 28, 2025: At 10:15 AM, Corey set up meeting “Business Check Ins” with no context.
- a) Meeting scheduled for: 1:00 PM same day.
  - b) At the meeting:
    - (1) Corey told me “if you were being fired, you would know.”
    - (2) I told Branham and Corey that giving us “Sorry!” board game on 8/21 was a distress signal.
      - (a) Mr. Corey then told me that I was likely making things up in my head and Ms. Branham resonated with him.
23. August 31, 2025: Corey called me twice at about 10:12 AM when I did not arrive at pickup spot for trip with van I was driving.
- a) Departure time: 10:15 AM, and hold back for stragglers.

- b) Corey told me to drive empty van to mall and back despite Branham instructing him not to (Branham told me this on Sept. 4 during 1:1 I had with her)

- 25. August 31, 2025: Approx. 2:55 PM, while I was in restroom at mall, I heard someone yell my name.
  - a) Voice sounded eerily similar to Corey's.
- 26. August 31, 2025: No communication from Corey that the group had left in entirety when I made it to van after restroom.
- 27. August 31, 2025: Corey texted me at 4:31 PM, "Make it back to campus alright?"
- 28. September 2, 2025: Corey emails me to ask about many work functions I was still catching up on.
  - a) Many tasks were ones delegated to student staff, as per his email.
  - b) One task was to inform Corey when the hall social for September would be so he could "stop and say hi to people."
- 29. September 4, 2025: Multiple Quid Pro Quo events, likely due to rejecting Dunkin' advance on 8/31.
  - a) At 1:31 PM, I respond to Corey's email and indicate my request for a Supportive Measure per 34 C.F.R. § 106.44.
    - (1) My response indicated, in part: I was still "processing the trauma" after "I nearly faced death as a result of the Title IX incident I experienced in July."
  - b) At 10 PM, first RA staff meeting of semester:
    - (1) My RAs gave me an agenda that included many complaints about my performance.
      - (a) First agenda item: "Balloons,"
        - (i) connects back to the "Business Check Ins" meeting on August 28, whose nexus was balloons (proximity of time).
      - (2) This agenda was written in prose uncharacteristic of student vernacular, and greatly deviated from the RAs' prose, as seen in attachments.

  - a) I was told during this meeting I was not permitted to continue in my role at Eastern or in any capacity.
33. September 18, 2025: Corey was nowhere to be found when I was walked off campus resultant from criminal trespass warning issued by Sgt. Fiore.
34. In December 2025, and up to the present day, Eastern and Mr. Corey are engaging in surveillance of my social media accounts directly and via proxy.
  - a) Proxies include, but are not limited to:
    - (1) my replacement as graduate intern hall director of Burnap
      - (a) TikTok username:
      - (b) The most recent viewing of my TikTok profile by was today - December 19, 2025.
35. December 10, 2025: Mr. Corey contacted me via TikTok Direct Message and asked me "What the hell is this post? You are accusing me of being your perpetrator???" regarding below post:
  - a) Link: <https://www.tiktok.com/t/ZTrtsCP4f/>
  - b) Shortly after, Corey blocks me on Burnap, Crandall, & Niejadlik Instagram pages.
    - (1) Link: <https://www.tiktok.com/t/ZTrtG18jU/>
36. December 10, 2025, approx. 3:32 PM: I tagged Eastern Housing on Instagram (username "@easternhousing") and was blocked after exposing Corey's message approx. 14 hours prior.
  - a) Link: <https://www.tiktok.com/t/ZTrtG18jU/>
37. December 18, 1:59 AM: Mr. Corey viewed my TikTok profile, which leads me to believe Mr. Serignese leaked the confidential settlement agreement proposal I drafted to Eastern and CSCU officials to Mr. Corey.
  - a) This third and final settlement proposal:
    - (1) Included Corey's name and
    - (2) Included one of my proposal terms to be Appointed via SUOAF-ASCME CBA to Residence Life Coordinator for Burnap, Crandall, and Niejadlik Halls.
    - (3) I have evidence, such as student support via TikTok and Instagram, that points to Mr. Corey's termination.
      - (a) Example: RA from Niejadlik following me Instagram on December 12 with a photo of a keychain.
        - (i) Keychain had cat Squishmallow on it, alluding to Roi, Corey's cat.
38. On December 19, 2025: I received a DoorDash order at around 11:45 PM, whose purchaser was "Joey C" and delivered Ben and Jerry's Phish Food ice cream and a Snickers ice cream bar to The Standard at Four Corners in Storrs, CT.
  - a) On my discharge day (September 18, 2025), I had an unfinished tub of Phish Food in my freezer, and Mr. Corey told me on or around August 25, 2025, that he enjoys Snickers ice cream bars.
    - (1) When I arrived to deliver there, I was instructed via DoorDash to meet at the roundabout at the complex.
    - (2) I messaged Joey via the app and received no response.

- a) Example: a two-paragraph text message on my first weekend to tell me that my Hall Director apartment shower was out of service.
40. Between June 6, 2025, and August 22, 2025: Engaged in Microsoft Teams chat messages with me that were of a monitoring nature.
- a) Example: Entering my office without my express permission.
41. Between June 6, 2025, and August 28, 2025: He engaged in conversation during 1:1s that was of a more intimate than appropriate nature for as supervisor-subordinate relationship.
- a) Example: Shared with me that while he was enrolled in the SDHE program at Central, he would:
    - (1) alternate reading textbook chapters with classmates for class
    - (2) while enroute from Eastern via the I-84 West HOV lane
    - (3) he appreciates HOV lane cuts travel time in Hartford, CT.

  - C. I believe Dr. Kennedy's failure to grade the paper was due to the Residence Life Coordinator position was synonymous to Mr. Corey. As Dr. Kennedy would likely
  - D. Since Mr. Corey is an SDHE alumnus, Dr. Kennedy's failure to grade the paper was a retaliation measure against me to protect the institutional "integrity," - i.e., loyalty - of CSCU, which would encompass Central.
  - E. **Irreparable Harm:** This failure to grade my paper for 13 calendar days sans updates caused me to withdraw from the SDHE program and is actively hindering my ability to obtain future employment in the student services field.
    1. Example: I was just sent a rejection letter telling me my professional experience is insufficient for an Area Coordinator at Husson University.
  - F. **Emotional Distress:** November 5, 2025, was the second anniversary of my grandmother's death. When coupled with this, my emotional distress is increased.

  - a) Bassett-Cameron asserted that student affairs professionals are close.
    - (1) This leads me to believe she was engaging in conspiracy.
  3. That Title IX Coordinators have no allegiance to Complainants or Respondents.

**RETALIATORY TERMINATION - VIOLATION OF 34 C.F.R. § 106.71**

***Central Admission of Eastern Medically Coercing Hospital - TORT OF FALSE IMPRISONMENT***

- I was scheduled to be discharged on September 17, 2025, but Mr. Serignese and Ms. Delaney requested that I stay in the hospital one more day because they were “figuring out a plan” for me to retrieve my items from my hall director apartment.
  - The medical coercion was against social worker’s orders.
- Central’s Interim Director of Counseling & Student Services, Kristen Dignazio-Drost affirmed this in front of their Assistant Dean of Student Affairs, Dr. Kate Ayotte and Victim Advocate Lisa Leggett.

***Termination via Criminal Trespass Warning Sans Due Process***

***Sequence of Events after Admission on September 8, 2025***

- September 7: I was evaluated at the hospital ER,
  - I informed a social worker that I wanted to throw things at some of the resident assistants and wanted help to not allow things to get that far. The hospital communicated this information to Mr. Serignese via cellphone.
- On September 8, Eastern sent Mr. Serignese to the hospital to retrieve my keys “just in the short term...just to mitigate the risk” due to my desire to throw things at the RAs.
- While hospitalized: I requested a Supportive Measure of either
  - a new living space, or if that could not be reasonably accommodated,
  - a new mattress, to my social worker at Rockville General Hospital’s adult psychiatric ward.
- My Supportive Measure request was never addressed by any Eastern officials until I reached out to Mrs. Judge on October 10, 2025 via email.
- On September 18, 2025, I was discharged from the hospital at about 1 PM.
- On September 18, 2025, as soon as I returned to campus, Mr. Serignese asked me to sign a resignation letter, which I refused to sign.
- I was then told to go to Ms. Branham’s office. When I went to Ms. Branham’s office, I was issued a trespass warning by Sgt. Fiore, a campus police officer.
- Sgt. Fiore did not inform me the reason for the trespass warning issuance.
- Sgt. Fiore initially wrote “ECSU Housing” for the location,
  - He then added “/All Campus” after I questioned if I was permitted to visit other parts of campus.
  - I took this as retaliation for requesting a federally regulated accommodation via 34 C.F.R. § 106.
- Despite a FOIA Request and FOIC Appeal in November of 2025, I have not received a copy of ECSU Police Report 25-15236. I believe Mr. Corey falsely accused me of a crime
  - False police reports in Connecticut are punishable by law.

**ACTUAL FINANCIAL HARM DUE TO DELIBERATE INDIFFERENCE**

- On September 19, 2025, I filed for unemployment.
- On September 30, 2025, I received an email from Eastern HR, informing me that a fraudulent unemployment claim had been submitted on my behalf. The email confirmed that I was "actively employed" by Respondent.
- On November 4, 2025, I received a notice from CT Dept. of Labor stating that Eastern informed them I "voluntarily quit..."
- On December 7, 2025, I emailed CSCU to demand they correctly inform CT Dept. of Labor that I was involuntarily terminated.
  - The email was ignored.
    - Dr. Atkins served Mr. Serignese with a Respondent Notice on December 1, 2025, which indicated that I was "involuntarily terminated"
